Haul-out Work Order and Contract – Page 2

- I. This agreement is for boat storage and will serve as notice of the Michigan Marina and Boatyard Storage Lien Act (PA 362 of 1998) should filing of a lien become necessary.
- II. This agreement covers only the items requested on the reverse side.
- III. Heated indoor storage does not require that the boat be winterized.
- IV. At least two (2) weeks notice is requested to have a boat taken out of the water on a specified date. If the owner or owner representative will not be present, keys must be left at the marina office (or combination, if applicable) so that the boat can be moved. Two (2) weeks notice is again requested to have a boat put back into the water in the spring.
- V. The total storage contract payment is due at the time of haul-out. Any unpaid balance will be assessed a service charge at the rate of 1 ½% per month on the outstanding account balance.
- VI. Additional storage charges will be made on any boat still in storage after Memorial Day and through Labor Day. Charge rate will be \$.50 per lineal foot per day, unless other arrangements have been made. The applicable seasonal rate will be charged if the boat remains for long term storage. The conditions of this contract will remain in effect until such time as the boat leaves TMI.
- VII. Storage is at sole risk of the boat owner. TORRESEN MARINE, INC. (TMI) is not responsible for damage, loss, or theft of any kind to boat, gear, or equipment. Sails stored are not covered for damage resulting from insects, birds, rodents and other animals. TMI does not carry fire or any other insurance on stored boats. The boat is insured only during handling and transporting. TMI strongly recommends that the boat owner carries their own insurance. TMI strongly recommends that the owner not leave personal items on the boat while in storage. TMI assumes no responsibility for personal property or electronics left on the boat during storage.
- VIII. No boat may be plugged into electricity overnight. Cords left out overnight may be confiscated.
- IX. Owner is responsible for the care and maintenance of their cradle or trailer. TMI has the right to deem a cradle unfit for use if necessary. Any rental or repair costs applicable will be charged to the owner.
- X. The yard facilities shall not be used for solicitation, advertising or any other business purposes except by the yard and its permittees.
- XI. The boat owner, having read and agreed to this contract, the terms stated above, and the charges on the attached sheet signs page one (1) of this form.
